The Speed Skating competition will be conducted in accordance with the latest edition of the *International Skating Union (ISU) Special Regulations and Technical Rules for Speed Skating*. Detailed information is available on the official website of the International Skating Union (ISU). In case of any

disagreement in the interpretation of the competition rules, the English version of the ISU Special Regulations and Technical Rules for Speed Skating shall prevail.

Any unforeseen circumstances not covered by the regulations and rules shall be resolved as follows:

- General issues: Resolved in accordance with the *OCA Constitution and Rules* and the *Sport Technical Handbook*.
- Technical issues: Resolved by the Technical Delegate and the Referee in accordance with relevant ISU regulations and rules.

#### 1.8 Eligibility

- Only NOCs that are members of the OCA are entitled to send their athletes to compete in the Speed Skating competition of the 9th Asian Winter Games Harbin 2025.
- Only athletes who comply with the *OCA Constitution and Rules* and the *Sport Technical Handbook* are entitled to compete in the Speed Skating competition.
- Age requirement: Participating athletes must be born on or before 1 July 2007.

- Each NOC may send team leaders and coaches to attend the meeting. An interpreter or accompanying person may also attend the meeting if necessary.

#### 1.11.1 Draws

The draw to determine the starting order shall be conducted in accordance with the ISU Special Regulations and Technical Rules for Speed Skating.

## 1.12 Protests and Appeals

Protests and appeals shall be resolved as per the International Skating Union (ISU) Constitution and General Regulations, as well as the ISU Special Regulations and Technical Rules for Speed Skating. Any disputes not resolved under the ISU Constitution and General Regulations, the ISU Special.

Regulations and Technical Rules for Speed Skating, or the OCA Constitution and Rules may be submitted to the Court of Arbitration for Sport (CAS) for resolution.

## 1.13 Equipment and Clothing

#### 2.6 Training Schedule

The official on-ice training sessions for athletes are scheduled from 5 to 6 February 2025 at the competition venue. The detailed schedule is TBD. The unofficial training sessions can be reserved from 3 to 4 February 2025. The Weight Room will be available for participating teams. It will be equipped with complex training equipment.

#### 2.7 Competition Rules

The Short Track Speed Skating competition will be conducted in accordance with the latest edition of the *International Skating Union (ISU) Special Regulations and Technical Rules for Short Track Speed Skating*. Detailed information is available on the official website of the International Skating Union (ISU). The Short Track Speed Skating competition uses the "0 False Start" procedure.

In case of any disagreement in the interpretation of the competition rules, the English version of the ISU Special Regulations and Technical Rules for Short Track Speed Skating shall prevail.

Any unforeseen circumstances not covered by the regulations and rules shall be resolved as follows:

- General issues: Resolved in accordance with the OCA Constitution and Rules and the Sport Technical Handbook.
- Technical issues: Resolved by the Technical Delegate and referees in accordance with relevant ISU regulations and rules.



#### 2.8 Eligibility

- Only NOCs that are members of the OCA are entitled to send their athletes to compete in the Short Track Speed Skating competition of the 9th Asian Winter Games Harbin 2025.
- Only athletes who comply with the *OCA Constitution and Rules and the Sport Technical Handbook* are entitled to compete in the Short Track Speed Skating competition.
- Age requirement: Participating athletes must be born before 1 July 2007.

#### **2.9 Entry**

- Total: Each NOC may enter a maximum of six (6) male athletes and six (6) female athletes.
- Individual Events: Each NOC may enter a maximum of three (3) athletes per event.
- Relay Events: Each NOC may enter a maximum of one (1) team per event. For the Men's 5000m Relay and Women's 3000m Relay, each team may consist of up to six (6) athletes. For the Mixed Team 2000m Relay, each team may consist of up to four (4) male athletes and four (4) female athletes.
- Best Time: Names of the skaters and their personal best time recorded for all distances they might participate in for each of the competitions over the individual distances, if applicable.

## **2.10 Competition Format**

The competition is held in a single-distance format, following the requirements of the *ISU Qualification Table*. The Competitors Steward(s) will conduct drawing procedure as per the *ISU Special Regulations and Technical Rules for Short Track Speed Skating*.



#### 2.11 Technical Meeting

- The Technical Meeting (Team Leaders Meeting) is tentatively scheduled at 20:00 on 6 February 2025 (specific location TBD).
- Each NOC may send up to two (2) representatives to attend the meeting. An interpreter or accompanying person may also attend the meeting if necessary.

#### 2.12 Protests and Appeals

Protests and appeals shall be resolved as per the International Skating Union (ISU) Constitution and General Regulations, as well as the ISU Special Regulations and Technical Rules for Short Track Speed Skating. Any disputes not resolved under the ISU Constitution and General Regulations, the ISU Special Regulations and Technical Rules for Short Track Speed Skating, or the OCA Constitution and Rules may be submitted to the Court of Arbitration for Sport (CAS) for resolution.

## 2.13 Equipment and Clothing

All equipment, clothing and protective gears must comply with the *ISU Special Regulations and Technical Rules for Short Track Speed Skating* and the requirements specified in the latest ISU notifications. They must receive check before the competition. NOCs must provide test reports for cut-resistant protective clothing (level three or above) upon arrival. Any safety issues caused by equipment and clothing during the pre-Games training sessions or competition sessions should be the responsibility of the respective competing NOCs.

In case of any disagreement in the interpretation of the competition rules, the English versions of the *ISU Constitution and General Regulations* and the *ISU Special Regulations and Technical Rules for Single & Pair Skating and Ice Dance* shall prevail.

Any unforeseen circumstances not covered by the regulations and rules shall be

- Only athletes who comply with the OCA Constitution and Rules are entitled to compete. Eligibility for this sport does not require a minimum ISU technical score.
- Age requirement: Participating athletes must be born on or before 1 July 2007 (subject to change based on the latest edition of the ISU rules).

## • Team Leaders Meeting

The Team Leaders Meeting will be held at the competition venue on 10 February 2025. Each NOC may send a maximum of two (2) representatives to attend the meeting. An interpreter or accompanying person may also attend the meeting if necessary.

## • Initial Judges Meeting

The Initial Judges Meeting is moderated by the Referee and the Technical Controller, and is held the day before the competition or during the official training sessions. All Judges are required to attend. The Technical Controller could attend If possible.



#### • Technical Panel Pre-Event Meeting

The Technical Panel Pre-Event Meeting is moderated by the Technical Controller for each event. Technical Specialists and Data Operators for each event are required to attend. The meeting is held the day before the competition or during the official training sessions.

#### • Judges Round Table Discussion

The Judges Round Table Discussion is held separately for each event after the competition concludes. It is moderated by the Referee and the Technical Controller, and all Judges are required to attend. The Technical Controller could attend If possible.

#### • Technical Panel Discussion

The Technical Panel Discussion is held separately for each event after the competition concludes. It is moderated by the Technical Controller, and Technical Specialists and Data Operators are required to attend.

#### 3.10.2 Team Leaders Meeting Agenda

The meeting will be chaired by the Competition Manager and conducted in English. The specific agenda is shown as below:

- The Venue Manager delivers an opening address;
- The Technical Delegate delivers an address;
- The representative of the OCA delivers an address;
- The Competition Manager introduces the relevant instructions on the competition;
- The Medical Officer introduces the related medical services-related issues;

#### **4.10 Competition Format**

- Men's Ice Hockey: Six (6) teams in Division I and six (6) teams in Division II Teams play in groups in a single round robin format. The three-point system will be in use, with three (3) points for a win, and zero (0) for a loss within the 60-minute regulation time. If the scores are tied at the end of the regulation time, an overtime or a shootout will be played, with two (2) points added for a win and one (1) point added for a loss. In a case that the scores are tied after a single round robin, the competition shall follow the *IIHF Sport Regulations* (2022/2023-2023/2024). A five-minute sudden-death overtime period will be played, with each team send three (3) players and one (1) goaltender. In the event of a tie at the end of the overtime period, there will be a shootout.
- Women's Ice Hockey: Four (4) teams in Division I and four (4) teams in Division II Teams play in groups in a single round robin format. The three-point system will be in use, with three (3) points for a win, and zero (0) for a loss within the 60-minute regulation time. If the scores are tied at the end of the regulation time, an overtime or a shootout will be played, with two (2) points added for a win and one (1) point added for a loss. In a case that the scores are

tied after a single round robin, the competition shall follow the *IIHF Sport Regulations* (2022/2023-2023/2024). A five-minute sudden-death overtime period will be played, with each team send three (3) players and one (1) goaltender. In the event of a tie at the end of the overtime period, there will be a shootout.

#### 4.11 Technical Meeting

Technical Meetings for the Ice Hockey competition include Pre-game Technical Meetings and Games-time Technical Meetings. Special requirements for the competition are clarified during the Pre-game Technical Meetings. Before the Ice Hockey competition, each group will hold Head Coaches 'Rule Information Meeting (HCRIM), Team Medical Personnel Meeting (chaired by Medical Supervisor), Passport Control Meeting and Competition Committee Meeting for Ice Hockey.

#### **4.12 Protests and Appeals**

The Ice Hockey competition of Harbin 2025 will be conducted in accordance with the *IIHF Sport Regulations* and related IIHF regulations.

Any unforeseen circumstances not covered by the regulations and rules shall be resolved as follows:

- General issues: Resolved in accordance with the OCA Constitution and Rules.
- Technical issues: Resolved by referees and Technical Delegate in accordance with the IIHF regulations.
- In case of any disagreement in the interpretation of the competition rules and regulations between this *Sport Technical Handbook* and the *OCA Constitution* and *Rules* and the relevant IIHF regulations, the *OCA Constitution and Rules* and relevant IIHF regulations shall prevail.

#### **5.10 Competition Format**

Eight (8) ends are scheduled with extra end(s) to break tied games. A minimum of six (6) ends must be completed in all games.

The competition will be held in group round robin as well as qualification games, semi-finals and finals format. According to the ranking of each participating NOC on the World Curling ranking list, groups will be formed in snake shaped arrangement.

## **5.11 Technical Meeting**

## 5.11.1 Technical Meeting

Technical Meetings for the Curling competition include Pre-event Technical Meeting and Post Round Robin Team Meetings.

Pre-event Technical Meeting: Teams are reminded that the current World Curling

Rules of Competitions states that one player and one team official must attend the Team (Technical) Meeting. When a team has no team official(s) registered, two players must attend the meeting. If a team has more than one accredited official, two team officials and one player can attend.

Failure to attend without approval of the Chief Umpire, results in the forfeit of the last stone advantage for that team in its first game.

Teams are also reminded that their representatives are responsible to pass along all information that is discussed at the team meeting and that all team members and team officials are bound by that information whether they attended the meeting or not.

Post Round Robin Team Meetings: Relevant participating teams must select one (1) or two (2) team members (players and/or coaches) to attend the meeting.

A team not represented at the post round robin meeting, or is not prepared to decide, forfeits the choices to which the team is entitled. Post round robin team decisions can be submitted earlier in writing by a team if the CU gives permission.

#### 5.11.2 Date and Location

The date and location of Technical Meetings will be adviced when the competition schedule is finalized.

#### 5.11.3 Meeting Agenda

The meeting will be conducted in accordance with the World Curling Technical Official Manual.



## **5.12 Protests and Appeals**

Protests shall be resolved as per the latest edition of the World Curling *Rules of Curling and Rules of Competition*. All protests and appeals relating to the competition rules shall be decided by the Chief Umpire. Any dispute not resolved under the World Curling Rules of Curling and *Rules of Competition* or the *OCA Constitution and Rules* may be submitted to the Court of Arbitration for Sport (CAS) for resolution.

#### 5.13 Equipment and Clothing

- The Venue Manager delivers an opening address;
- The Technical Delegate delivers an address;
- The representative of the OCA delivers an address;
- The Competition Manager introduces major referees and relevant instructions on the competition;
- The Technical Delegate explains technical matters related to the competition;
- The Medical Officer introduces medical services-related issues;
- The Weather Services Team introduces weather services-related issues.

#### 12.11.2 The First Team Leaders Meeting

The first Team Leaders Meeting is tentatively scheduled at 17:00 on 10 February 2025, with the specific location to be determined. Each NOC may send a maximum of two (2) representatives to attend the meeting. An interpreter or accompanying person may also attend the meeting if necessary.

According to the requirements of the *IBU Event and Competition Rules*, each participating team shall submit the entry list for the Women's and Men's Sprint events to the Competition Office before the first Team Leaders Meeting.

The meeting will be chaired by the Race Director and conducted in English. The specific agenda is shown as below:

- Roll call;
- Introduction of Attendees;



- Election of the Jury of Appeal;
- Draw for Women's Sprint events;
- Draw for Men's Sprint events;
- The Race Director introduces the competition(s);
- The Technical Delegate delivers an address;
- Weather forecast; and
- Distribution of Starting Order Lists and Bib Numbers.

#### 12.12 Protests and Appeals

Protests and appeals regarding the competition shall be resolved in accordance with the *IBU Event and Competition Rules*. Any dispute not resolved under the aforementioned *Rules* or the *OCA Constitution and Rules* may be submitted to the Court of Arbitration for Sport (CAS) for resolution.

#### 12.13 Equipment and Clothing

All competition equipment and clothing will comply with the *IBU Event and Competition Rules*.

The Ski Mountaineering competition of Harbin 2025 will be conducted in accordance with the latest edition of the *International Ski Mountaineering Federation (ISMF) Rules & Guidelines*. For detailed information, please visit the official website of the ISMF In case of any disagreement in the interpretation of the competition rules, the English version of the *ISMF Rules & Guidelines* shall prevail.

Any unforeseen circumstances not covered by the rules shall be resolved as follows:

• Technical issues: Resolved by the Jury of Appeal convened by the Technical Delegate and Jury President, in accordance with the relevant ISMF regulations.

# 13.8 Eligibility

- Only NOCs that are members of the OCA are entitled to send their athletes to compete in the Ski Mountaineering competition of Harbin 2025. Only athletes who comply with the OCA Constitution and Rules Eligibility Code are entitled to compete in the Ski Mountaineering competition.
- Age requirement: Participating athletes must be born on or before 31 December 2008.

#### 13.11.2 Draws

The starting order for the first round of events (Sprint and Mixed Relay) will be determined by a draw conducted on-site by the Technical Services Team.

#### 13.12 Protests and Appeals

- Protests and appeals will be handled according to Articles 30.3, 30.3.1 and 30.3.2 of the *ISMF Rules & Guidelines*.
- In the Quarterfinal and Semifinal of the Sprint event, no protests will be accepted on decisions of infringements or non-infringements.
- Protest Deadline

Protests must be submitted to the Jury of Appeal immediately, no later than five (5) minutes after the conclusion of the relevant competition.

• Protest Format

Protests must be submitted in writing.

• Language English

# 13.13 Equipment and Clothing

All competition equipment, clothing and protective gear must comply with the ISMF Statutes and the latest edition of the *ISMF Rules & Guidelines*. During the competition (pre-competition and post-competition), participating athletes must unconditionally submit to equipment checks by Technical Officials.



# **Appendix**

According to the *OCA Constitution and Rules*, NOCs participating in the 9th Asian Winter Games Harbin 2025 shall follow the following eligibility:

#### **Article 52: Eligibility Code**

To be eligible for participation in the OCA GAMES, a competitor must:

- 1. Observe and abide by the Rules of the IOC/OCA as per the Olympic Charter;
- 2. Respect the spirit of fair play and non-violence and abide by the rules on the sports field;
- 3. Comply with all aspects of WADA and OCA Anti-Doping Rules Code and refrain from using substances and drugs prohibited by the said organisations;
- 4. The Member must ensure that any competitor in the OCA GAMES must be a national of the country of the NOC, which is entering him;
- 5. Disputes relating to the determination of the country which a competitor may represent in the OCA GAMES shall be resolved by the EB, unless the eligibility code already set out in the Constitution has been fulfiled and is not in dispute.

# **Bye-law to Article 52**

- 1. All cases of infringement of IOC Rule 41, 42 and it's Bye-laws and of the eligibility code of IFs shall be communicated by the concerned Member to the OCA, to be considered by the EB whose decision will be final
- 2. A competitor who is a national of two (2) or more countries at the same time may represent either one (1) of them, as he may elect. However after having represented one country in the Olympic, Asian continental regional or world championships recognised by the relevant IF, the competitor may not represent another country unless he or she meets the conditions set forth in sub section 4 below that apply to the persons who has changed his nationality or acquired a new nationality;



- 3. A competitor who has represented one country in the Olympic Games, OCA GAMES, continental, regional, and world championships recognised by the relevant IF, and who has changed his nationality or acquired a new nationality, shall not participate in the OCA GAMES to represent his new country until three years after such change or acquisition;
- 4. If a State, Country or a colony acquires independence, a country becomes incorporated within another country by a change of border or transfer of sovereignty or if a new NOC is recognised by the OCA, a competitor may continue to represent the country to which he belong or belonged. However, he may, if preferred, choose to represent his country or be entered in the OCA GAMES by his new NOC if one exists. This option can only be made once and is irreversible;
- 5. In all cases not expressly addressed in these Bye-Laws, in particular those cases where a competitor would be in a position to represent a country other than that of which he is a national, or to have choice as to the country which he intends to represent, the EB makes all decisions. Decisions can be of a general or individual nature and issue specific requirements relating to nationality, citizenship, domicile or residence of the competitors, including the duration of any waiting period;
- 6. Except as permitted by the EB, no competitor, coach or official who participates in the OCA GAMES may allow his person, name and picture or sports performances to be used for advertising purposes during the OCA GAMES.

# **Article 53: Necessary Conditions for representing a Country**

1. Only nationals of member NOCs are eligible to represent that country in the OCA GAMES. Where a competitor's nationality is the subject of scrutinization, evidence (passport, residency & other documents) must be produced to support and meet definition of eligibility, according to the rules prevailing in the

particular sport in which the competitor wishes to take part. It is not permissible for a competitor having once represented a country in the OCA GAMES or any international sports competition such as Olympic Games, Asian Games, World Games, Continental Games, Regional Games etc., to represent a different country in the future unless:

- a. The former country or place of birth has since been incorporated in another State:
- b. Or if he/she competed for the former country because the NOC or Chief National Organisation of their native land was not a Member of the OCA at that time:
  - c. The rules in relation to Article 49 byelaw 4 are met.
- 2. Competitors will be eligible if they comply with the following qualifications:
  - a. That they were born in the country they represent;
- b. That they are nationals or citizens of the country they represent and have lived there continuously for a period of not less than three years;
- c. That they have become naturalised in the country they represent and have permanent residence there.
- 3. Competitors born outside Asia cannot be qualified unless they meet conditions in 2 b & c, where applicable.

# **Bye-law to Article 53**

The OCA will have the full authority for disqualification of any athlete in all matters other than technical.

# **Article 54: Age Limit**

There is no age limit for competitors in the OCA GAMES, unless the IF and/or AFs prescribe otherwise and is approved by the EB apart from AYG which has an age restriction of 14-17 years.
