

## <u>DECISIONS 102<sup>nd</sup> OCA Executive Board Meeting</u> <u>Held on Thursday 6<sup>th</sup> November 2025 Online 10am Kuwait time</u>

- 1. Minutes of the 100<sup>th</sup> and 101<sup>st</sup> OCA Executive Board Meeting held on 16<sup>th</sup> October 2025, and 22<sup>nd</sup> October 2025 respectively were unanimously approved by the Board.
- 2. The Board unanimously approved the recognition of
  - i) Padel Asia
  - ii) Asian Kho Kho Federation
  - iii) Asian Korfball Federation
- 3. The Board unanimously approved
  - i) Financial Statements for the 9-month period ending 30<sup>th</sup> September 2025.
  - ii) Minutes of the Finance Committee held on 16<sup>th</sup> October 2025 were unanimously approved by the Board.
  - iii) Report of the Audit & Risk Committee Meeting held on 11<sup>th</sup> October 2025 was unanimously approved by the Board.
- 4. Officially request the future Asian Games Organizing Committees to include Teqball and Padel as a medal sport.
- 5. Officially request Sanya Asian Beach Games Organizing Committee to include Teqball, Padel & Air Badminton as a medal sport.
- 6. Water Polo in Sanya will be Beach Water Polo edition which is 4x4 players.
- 7. The Executive Board unanimously appointed the Coordination Committee for the 4<sup>th</sup> Asian Youth Games to be held in Tashkent in 2029. The CC will consist of
  - 1. Mr. Mohammad Tayyab Ikram Chair
  - 2. Mr. Jeevan Ram Shrestha, President NOC of Nepal
  - 3. Mr. Ata Akmammedov SG NOC Turkmenistan
  - 4. Mr. Khalid Mahmood, SG NOC of Pakistan



- 8. Authorized the Director General OCA to discuss and sign the new Host City Contract (HCC) with the NOC and Organizing Committee of Tashkent Asian Youth Games for 2029.
- 9. Should the host NOC decide not to host a game after signing the HCC then they will forfeit their refundable bank guarantee and subject to further penalties by the Executive Board as proposed by the Legal Committee.
- 10. Authorized the Director General OCA to discuss and sign any documents legal or others in relation to the 2029 HCC for the Asian Winter Games with the NOC of Saudi Arabia and also authorized the Director General to finalize all arrangements for any potential future host for Winter Asian Games.
- 11. The Board unanimously decided to register the OCA logo without the Olympic Rings in all the 45 NOCs of Asia. Later, if the IOC provides approval, then the Olympic Rings can be added to the Logo.
- 12. The composition of the voting athletes as proposed by the Legal Committee to be deferred till after the OCA Athletes Committee has discussed and provided their final recommendation.
